1.1 General part

1. Regulations for Hjøllerup Market - General Part - must at all times be followed. The regulations are available at www.hjallerup-marked.dk.
2. Everyone attending the Marketplace must follow instructions from the committee's managers and the Market Committee.
3. We encourage good behavior, and therefore no one should show inappropriate behavior to the guests, customers, staff, emergency staff, guards and others.
4. Barkers, like everyone else at Hjøllerup Market, must follow the laws and regulations.

1.2 Specific Part

1. All market stalls must have a yellow sign placed visibly at the front of the stall. Each Barker has an individual area and barker number. These are displayed on the yellow sign. **The yellow sign is distributed in the Information when you report your arrival.**
2. Small animals and accessories in this regard, are only allowed to be sold in the area of small animals unless otherwise agreed with and approved by the organizer. It is not permitted to sell dogs or cats at Hjøllerup Market.
3. Electrical connection is made in installed sockets / boards. Power connection is performed by the marketplace electrician. 30 meters of cable must be brought by each barker. The marketplace electrician can connect several market stalls to the same security group. There will be electricity at the Marketplace as of Tuesday in the "market week".
4. On the Market stall, activities such as Tivoli and the like, e.g. lottery games cannot take place.
5. It is not allowed to sell or give away free food or beverages of any kind.
6. The Market stalls must be set up no later than Wednesday at 18:00, otherwise it will be sold to another without refund of deposit paid.
7. The Market stalls must be closed Wednesday at 01:00am, Thursday, Friday and Saturday at 2:00am and Sunday at 18:00 p.m.. The dismantle cannot take place earlier than Sunday at 18:00 in consideration of market guests and the other barkers. If this is not respected you cannot expect to be allocated a stall for next year.
8. The Market stall **may not** be transferred or sold to a third party.
9. All Market stalls (barkers and small animals) must be paid on time – otherwise the stall will be sold to another.
10. Cancellation of the stall must be done by May 1st at the latest. Hereafter, there is no refund of paid rental. In case of cancellation before and at the latest on May 1st the rental will be returned minus an administration fee of 300 dkk.
11. Technical regulations for assembly tents, corporate houses, sales areas and camping areas that are not included in the camping regulations specified by the Emergency authorities and other legislation must be respected by each Barker. All tents above 50m² must be certified otherwise a building permission is required cf. no. 880 of 03 July 2014 regarding certification scheme for transportable tents and constructions. Building permission from Brønderslev Municipality or certificate must at any time be displayable for authorities.
12. Each Barker must bring and set up at least one approved fire extinguisher.
13. A maximum of one 11kg gas bottle per stall. All gas installations must comply with the gas regulations. **Market stalls with gas bottles have to be clearly signed with statutory text "Gas bottles are removed in case of fire". The sign is available in the Information office.**
14. The use of open flame, barbeque and the like is strictly prohibited at the stall and nearby the stall.
15. The Market stall is the responsibility and insurance of the Barker. Exhibited goods need to be within the frontage of the stall. All free areas must be kept free of exhibited items etc
16. The rear area of the stall, must be properly closed for the market guests.



17. The Barker is responsible for keeping the street in front of the stall cleared and free of waste. In the case of corner places, the barker must also keep the street off the gable cleared and free from waste.
18. Flammable waste must be delivered to the waste station at the Materielgård behind the Market hall and is not to be dumped at the Marketplace. Find the regulations for waste at www.hjallerup-marked.dk
At each market stall it is allowed to place one waste container with a capacity of max. 1m³ for smaller amounts of waste. The container has to be emptied at least once a day.
19. The Market stall and the area in front have to be returned in a clean condition no later than the day after the end of the market at 17:00.
20. In case of fire, immediately contact the Information on +45 9828 2020 or get hold of one of the guards who immediately will assist in calling the necessary help.
21. The Samaritans are located south of the Markedskroen – entrance 14 at Algade opposite the Mechanical Museum. If any questions, please contact the Information - +45 9828 2020
22. In case of urgent help: Call 112. or contact the Market samaritans.
23. All driving at the Market place should be limited in consideration of the market guest. During the market days it is NOT allowed to drive in the Market place after 10:00.
24. Parking at the Marketplace is not allowed. Excluded from this are up to two vehicles with direct connection to the market stall. Parking must be within the market stall lines. This is valid from Wednesday evening in the market week. All vehicles parked in the Marketplace must be provided with the owner's telephone number, which must be placed visibly in the windscreen. Vehicles above 3,500 kg can not be parked with the keys in the ignition. **It is not at any time permitted to park in the Barker streets.**
25. By contacting the Information you can get ONE parking ticket
26. Accommodation for necessary staff is permitted if supervision of the stall is required. All accommodation is at your own risk.
27. At Hjørring Idrætscenter, Idræts Allé 1, you have the opportunity, in a certain time period, to get a bath. The opening hours can be seen in the Information. It costs 20 DKK. Barkers can also get a bath at the Marketplace. It costs DKK 20, and the tokens can be purchased in the information.
28. Hjørring Marked takes no responsibility for the exhibited and displayed goods / effects.
29. Hjørring Marked takes no responsibility for traffic and weather conditions.
30. When the Market Stall rental is paid, the owner of the stall has the right to apply the municipality for the necessary building permission to establish a tent on the leased stall.
31. Violation of this Code of Conduct and violation of decisions and instructions of the organizer may result in exclusion from the Market - and in estimated cases with the Police Assistance. In case of exclusion the stall rental is not refundable.
32. Hjørring Marked reserves the right to make claims for damages in case of violation of this Code of Conduct.
33. Concerning sale of goods for consumption, we refer to the Danish Veterinary and Food Administration website.
34. You can only reserve the market stall for the coming year by paying the deposit of 700 DKK during the market days by contacting the Information.

This regulation replaces all previous Market stall regulations for Hjørring Market.
